

# Privacy Policy

## **1. Introduction**

EV Solar respects your privacy and is committed to protecting your personal information that you provide to us. This Privacy Policy explains our policies and practices regarding the collection, use and disclosure of your personal information by EV Solar. We review and may update this Privacy Policy from time to time without notice (so you should review it periodically). By using our website and/or submitting your personal information, you consent to our collection and use of your personal information as described below.

## **2. Personal Information Collected**

You have control over your personal information. In general, you can visit our blog or website without providing any personal information. However, if you choose to use the contact portal on our website, we may collect registration data—such as your name, email address, and any other information you voluntarily provide—in connection with your inquiries and our responses (“User Information”). If you are under 18 years of age, please do not submit any User Information to us.

## **5. Accuracy and Security**

The accuracy and security of your User Information is important to us. You may review and request updates to your User Information by contacting Empire Valorize, LLC. If you ask us to correct inaccuracies, we will attempt to do so in a timely manner. We are committed to taking reasonable administrative, technical and physical safeguards appropriate to our size and risk to protect your personal information from unauthorized access or use. We also endeavour to keep our User Information accurate, complete and current.

## **6. Cookies and Tracking Technologies**

We use “cookies” and similar tracking technologies. A cookie is a small data file that a website can transfer to a visitor’s device to keep records of the visit. Cookies help us recognise pages you’ve visited and improve your future visits. The only personal information a cookie contains is the information you provide yourself. Cookies cannot read data off your hard drive or from cookies created by other sites. If you prefer not to accept cookies, you can set your web browser to warn you before accepting cookies or to refuse all cookies. However, some secured portions of our website may require cookies enabled to function properly. You can still access most of the website’s public pages without accepting cookies.
